Revenue

So far in 2020, \$15,010.86 in revenue was generated from membership payments for 238 members. This includes payments made in the fourth quarter of 2020 for 17 2021 memberships.

Expenses

Nondiscretionary operational expenses to date include:

- GoTo Meeting monthly meeting cost.
- Teleconference costs for APHEO meetings categorized as 'Executive Meetings', 'Strategic Planning work group', 'Membership Engagement workgroup', and 'Other' (includes COVID-19 teleconferences).
- Annual membership fees for Marsh Insurance, CSAE, and OPHA.
- Annual website fee.

Discretionary operational expenses include:

- Gifts for retiring APHEO executive members.
- Exec transition meeting lunch.

For special projects, expenses include:

- Initial installment to Bond Associates for Conference Planning
- Lawyer review of conference planner contract and "Governance Review" related to Incorporation.

Notes:

¹GoToMeeting costs split with OPHE. Each association pays for their own toll-free usage. OPHE is invoiced quarterly.

²On April 25, 2019, the APHEO Executive approved a motion to reallocate, or earmark for the following year, the \$5,000 originally budgeted
